### TERMS OF SALE

These terms and conditions discipline the sale of products between A.P.C. (hereinafter referred to as the Seller) and the company specified in the order heading (hereinafter referred to as the Purchaser). Once the order is signed by the purchaser the order is considered as accepted, and, the purchaser is considered as having accepted all the general terms and conditions of sale as well as the specific ones, if any, the whole constituting the contract of sale between the parties.

**ARTICLE 1**  
The Seller allows the purchaser to sell its products only in the point of sale marked on the order heading. Therefore, the Purchaser undertakes neither to assign nor to distribute to any dealer or any other different point of sale the products purchased from the Seller without its prior written authorization.

**ARTICLE 2**  
According to the Law, it is strictly forbidden to the Purchaser to partially or totally reproduce the models and designs seen and/or bought from the Purchaser.

**ARTICLE 3**  
The order shall be considered as accepted only after written confirmation by the Seller. Nevertheless, the Seller keeps the right to cancel the order, even after confirmation, in the following circumstances:

Lack of financial complementary guarantees if the coverage by the credit insurance company is refused or inferior to the amount due.  
Purchaser's substantial breaches in the agreement regarding payments of previous or on going orders;  
Changes or alterations of the image of the Purchaser or of its point of sale;  
Assignment of lease or sale of the business as a going concern.

The Seller will not accept any partial or total cancellation of the order after 8 days from the date of the order heading.

Prices do not include transportation, custom clearance or transportation insurance, if not otherwise stated on the Order Heading or Order Confirmation. The Seller's liability on the goods sold ends with the loading of the goods on the transporter's / forwarder's means at the Seller's Warehouse.

Prices are those in force at the date of the order heading signature. They do not include V.A.T. The Purchaser declares to accept them under the conditions described on the order heading.

The terms and methods of payment are those indicated in the order heading and order confirmation. Should the payment be delayed, partially or totally, the Purchaser shall pay an interest equal to 1,4 % per month of delay, without having to give a legal injunction.

**ARTICLE 4**  
A reserve of property clause is applied to any sale (Loi du 12 Mai 1980). The goods sold remain the Seller's property until full payment of the price. The goods travels at the Purchaser's risk, whatever means and condition of transport may have been chosen. The purchaser shall inspect the packaging of the goods before unloading the transporter's means. The goods shall be inspected by the Purchaser immediately after their arrival. Claims for erroneous delivery, or quality of the goods shall be declared to the Seller within 8 days from receipt, under penalty of forfeiture.

**ARTICLE 5**  
A tolerated slight alteration in the execution of this contract, whatever the duration in time or frequency, will never be considered as an amendment to the contract.

In case one of the articles of these general terms and conditions of sale is declared void, in respect to the law or specific legal regulation applicable, this will not affect the validity of the rest of these general terms and condition of sales that will therefore remain fully valid.

**ARTICLE 6**  
In case of bankruptcy of the purchaser occurring between the confirmation of the order and its receipt by the purchaser, the seller will suspend the execution of this contract until confirmation of the order by the mandatory administrator appointed by the Court.

**ARTICLE 7**  
The sales governed by these conditions of sale shall be ruled by French Law. The original language of this contract is French (this being therefore a translation).

**ARTICLE 8**  
Any dispute which may arise between parties concerning the interpretation or execution of this contract, shall be subject the Tribunal de Commerce of Paris, France, whatever the circumstances (plurality of defendants or "appel en garantie") and even in the case of summary procedure.
